These reports contain the following information:

Student Assessment Data

- Includes the following three assessments: M-STEP (Michigan Student Test of Educational Progress), MI-Access (Alternate Assessment), and College Board SAT
- Presents assessment information for English language arts and mathematics for grades 3 to 8 and 11, and MI-Access science for grades 4, 7, and 11, compared to state averages for all students as well as subgroups of students.

School Accountability Data

 Includes information on schools' performance on various measures such as student proficiency and growth on state assessments, graduation, and attendance rates. Performance is measured on 0-100 index scales Reports schools identified under three federally required categories for further support: Comprehensive Support and Improvement, Targeted Support and Improvement, and Additional Targeted Support

Educator Qualification Data

- Identifies the number and percentage of inexperienced teachers, principals, and other school leaders
- Reports teachers who are teaching with emergency or provisional credentials

For the 2023-24 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). The Huron School District is happy to report no labels for any of our schools other than Universal Supports which indicates that each school is performing above the criteria used to identify other support categories. Huron School District has continued to focus on bold initiative three of the district's strategic plan to ensure a vertically and horizontally aligned curriculum with an emphasis this year on aligning local assessments to grade-level standards. The district has focused on discipline literacy in our secondary schools and the complete integrations of the literacy essentials in all elementary classrooms. The MICIP goals for HSD focus on improvement of literacy and numeracy by using a muti-tiered system of supports to ensure students receive instruction at the level in which they are ready to learn. Targeted intervention if needed is provided. The HSD has committed to the review and updating of the instructional resources to teach the district's curriculum that is aligned to state standards. Currently the district is reviewing for adoption for the start of the 2024-25 school year all ELA resources. Parent involvement opportunities include joining your child's building's MICIP Team, PTO and Booster programs.
