

# VOTER INFORMATION ABOUT THE WAYNE COUNTY EDUCATION ENHANCEMENT MILLAGE



## **Frequently Asked Questions:**

Q: What is being asked for voters to consider on the August 5, 2014 ballot?

A: Voters are being asked to approve a county-wide, two-mill, six year education enhancement millage.

#### Q: Why do the school districts in Wayne County need this money?

A: The per pupil foundation grant allocated to each district has been greatly reduced over the past several years for every district. Despite substantial reductions in expenses, school districts are still struggling to balance budgets without cutting programs which are designed to produce college or career-ready graduates.

#### Q: What will the money be used for by school districts?

A: How the money will be spent is up to each school district, but some of the options include: reducing class size, increased instructional time, technology upgrades, facility repairs and upgrades, among others.

#### Q: What is an "enhancement millage?"

A: It is a millage that if approved by voters, is assessed to all taxpayers in the county. It will be distributed on a per student basis to each public school district in Wayne County. It is the only additional millage state law allows to generate additional operating funds for school districts under Proposal A.

#### Q: How would the enhancement millage impact my taxes?

A: For every \$50,000 of market value property owners would pay approximately \$50.00 per year. This equates to less than \$4.17 a month and approximately 96 cents a week.

## Q: What is Wayne Regional Educational Service Agency (WRESA) and why are they involved?

A: WRESA is the Intermediate School District for Wayne County and by state law is the organization that must place the millage proposal on the ballot. **WRESA will not retain any of these funds and is required by law to distribute all of the tax revenues to the K-12 school districts in Wayne County.**
