Dear Parents/Guardians:

We are accepting applications for **limited** openings in the Huron School District for the fall 2021-2022 school year. You must reside within a Wayne County School District in order to apply for an opening. Please be advised of the following:

- Applications will only be accepted between Monday, May 1, 2021 and Friday, May 16, 2021, 4:00 p.m. and will be available at the Administration building or may be printed from the website www.huronschools.org. **Incomplete information will not be accepted and will automatically be disqualified.**
- If we receive more applications than openings for each grade level, a random lottery will be held.
- Applications of students who have been suspended or expelled within the past two school years will automatically disqualify your student's application.
- A copy of the student's **last report card** which shows attendance and grades, must be turned in with all applications for **grades 1 through 8**.
- If you are applying for a vacancy in grades 6-12 you must have the "Affirmation of Prior Discipline" form signed by you, your student and the student's current building principal to accompany their application. Incomplete forms will disqualify the application.
- If you are applying for grades 9-12 your student must have earned enough credits to be at the grade level that they are applying for. An **unofficial transcript** and a copy of their **last report card** which shows attendance must accompany their application. Failure to provide this information will disqualify the application.
- If you are applying for grades 9-12, please know that incoming freshmen are eligible to play athletics for Huron. 10-12th graders may be penalized from participating in athletics for a period of time. If you have any questions regarding this matter, please contact your current Athletic Director, or you may contact the Huron School District Athletic Director, at 734-783-0324.
- **Completed applications and all documentation can be mailed to the address listed above or emailed to: schoolofchoice@huronschools.org no later than May 16, 2021 4:00 p.m. Anything that is received or post-marked after this date will be disqualified.**

3. SOC students are expected to adhere to all rules and regulations, the Student Code of Conduct, and policies of HSD. In addition, they must comply with all SOC legislative rules and regulations.
4. Students who have been expelled from any school district and/or school, public or private, are not eligible for enrollment in HSD.
5. The Huron School District will not provide transportation for School of Choice students.
6. School of Choice students who are determined to be eligible for special education programming will be subject to the same placement procedures as resident District students and may be placed in appropriate programs outside the Huron School District in accordance with the Special Education cooperative agreement. **If the applying student has an IEP, it must be attached to the application.**
